WASA CRACKERS SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. BY SUBMITTING AN ENTRY, YOU AGREE TO ALLOW SPONSOR TO USE YOUR ENTRY IN SPONSOR'S COMMERCIAL MATERIAL, AS WELL AS AT SPONSOR'S WEBSITE OR SOCIAL MEDIA PLATFORMS.

SPONSOR: Barilla G&R Fratelli, Via Montova 166, 43122 Parma, Italy is the Sponsor of the "WASA Crackers Sweepstakes" ("Sweepstakes").

Sweepstakes entrants must be a legal resident of one of the fifty (50) United States or the District of Columbia who are at least eighteen (18) years of age at the time of entry. Void outside the United States and where otherwise prohibited by law. You may enter this Sweepstakes only as a natural person. Employees of Sponsor, Zeno Group and Sponsor's distributors, wholesalers and retailers, each of their respective affiliates, agents, officers, employees, subsidiaries, vendors, advertising and promotion fulfillment and/or judging agencies (collectively, the "Related Entities"), and the family members of each are not eligible to enter or win a prize in the Sweepstakes. SELECTION OF FOUR (4) WINNERS: All Entries received will be sorted by each of the four (4) designated WASA Social Influencers Blog Sites. One (1) Winner will be selected in a Random Drawing from among all eligible Entries received at each designated WASA Social Influencer Blog Site for a total of four (4) WASA Social Influencer Blog Site Winners. Odds of winning depend upon the number of eligible Entries received. The Random Drawing will be conducted on or about August 20, 2016. Limit one (1) WASA Social Influencer Blog Site Prize per household. In the event an unqualified number of Entries are received at a designated WASA Social Influencer Blog Site, not all Prizes will be awarded at the Sponsor's sole discretion. Potential Winners will be notified by the corresponding WASA Social Influencer. Potential Winners will be required to respond to the WASA Social Influencer Winner Notification Post within forty-eight (48) hours from notification or winner will be disqualified and that prize will be awarded to an alternate winner in a random drawing from all remaining eligible Entries received at that corresponding designated WASA Social Influencer Blog Site. All Winners will be required to complete sign and return a Prize Verification and (where permissible) a Publicity Release Form within three (3) days from attempted date of notification to claim prize.

SELECTION OF ONE (1) GRAND PRIZE WINNER: One (1) Grand Prize Winner will be selected from among all confirmed four (4) WASA Social Influencer Winners in a Random Drawing conducted on or about August 24, 2016. The Grand Prize Random Drawing will be conducted by Zeno Group, an independent judging organization whose decisions are final and binding in all matters relating to this Sweepstakes. If the Sweepstakes is terminated early, Sponsor reserves the right to select the Prize Winners in a random drawing from among all eligible Entries received at the time of termination and award the prizes at its sole discretion. The Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries. The Sponsor is not responsible for any problems or technical malfunctions of any telephone network or telephone lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or Entry to be received by the Sponsor due to technical problems, human error or traffic congestion on the Internet or at any web site, or any combination thereof, including any injury or damage to participant's or any other person's
